Complaint Form: Unlicensed Practice

Practicing veterinary medicine without a license is a violation of the Veterinary Medical Practice Act (Chapter 43-29 of the North Dakota Century Code) and is also a class B misdemeanor. For your information, copies of the pertinent sections of the Act are on the page 2 of this form; the full text of the Practice Act is available from our office, through the board's web site (www.ndbvme.org), in most public libraries, and in most law offices.

43-29-01.1. Definitions. As used in this chapter, unless the context otherwise requires:

8. "Practice of veterinary medicine" means to:

- a. Diagnose, treat, correct, change, relieve, or prevent animal disease, deformity, defect, injury, or other physical or mental conditions. The term includes the prescription or administration of any drug, medicine, biologic, apparatus, application, anesthetic, or other therapeutic or diagnostic substance or technique, the use of any manual or mechanical procedure for testing for pregnancy, or for correcting sterility or infertility, or to render advice or recommendation with regard to any of the above.
 - b. Represent, directly or indirectly, publicly or privately, an ability and willingness to do an act described in subdivision a.
 - c. Use any title, word, abbreviation, or letter in a manner or under circumstances that induce the belief the person using the title, word, abbreviation, or letter is qualified to do any act described in subdivision a.
 - d. Apply principles of environmental sanitation, food inspection, environmental pollution control, animal nutrition, zoonotic disease control, and disaster medicine in the promotion and protection of public health.
10. "Veterinary medicine" includes veterinary surgery, obstetrics, dentistry, chiropractic, acupuncture, and all other branches or specialties of veterinary medicine.

43-29-17. Unlawful practice of veterinary medicine - Penalty - Civil remedy. Any person who shall:

1. Practice veterinary medicine, surgery, or dentistry in this state without compliance with the provisions of this chapter;
2. Willfully and falsely claim or pretend to have or hold a certificate of registration issued by the state board of veterinary medical examiners; or
3. Willfully and falsely, with intent to deceive the public, claim or pretend to be a graduate of, or to hold a degree or diploma showing the satisfactory completion of a course in veterinary science in a school, college, or university recognized by the board; is guilty of a class B misdemeanor. In addition to the criminal penalty provided, the civil remedy of injunction is available to restrain and enjoin violations of any provisions of this chapter without proof of actual damages sustained by any person, upon application and unanimous vote of all members of the state board of veterinary medical examiners.
